Bridge Hanger Replacement: John Kingsmore has received the permits from the DOT for the bridge hanger replacement on Highway 92 and Interstate 96. Ted Harrison will do the

construction work and he will hire a third-party safety traffic company to manage the traffic on Interstate I-26, because the work will be done on the right outside lane north bound lane I-26 where the hanger is broken. The water at Sumner Road will be shut off for a day while this work is ongoing, and customers will be notified of this repair ahead of time.
